Explanatory Notes

Form of nomination of Candidate for the office of People's Deputy

The rules surrounding the submission of a nomination of a candidate for office as a People's Deputy are set out in Article 32 of the [Reform \(Guernsey\) Law, 1948](#).

The nomination form

Every nomination has to be made in writing on the form provided by the Presiding Officer of the States and delivered **in person** to the Presiding Officer at the Royal Court House between 9.00 am on Monday 12th May and 4.30 pm on Wednesday 14th May 2025.

a) Candidate

The candidate is required to fill out their full forenames and surname. However, the ballot paper will show either the candidate's forename and surname **or** such other forename and/or surname the candidate has stated they are commonly known as.

If you wish a commonly known name to be used it must be clearly shown on the nomination form. The Presiding Officer and Registrar-General of Electors reserve the right not to publish a commonly known name which is, or may be perceived to be, offensive or misleading.

b) Proposer and seconder

The nomination form must be signed by two persons (the proposer and the seconder) whose names **must** be inscribed on the Electoral Roll. It must be signed and dated showing the date of nomination.

Declaration of eligibility and unspent convictions

Every nomination must be accompanied by a declaration in writing signed by the candidate declaring:

- a) the person is eligible under the provisions of Article 8 of the [Reform \(Guernsey\) Law, 1948](#) to hold the office of People's Deputy.

ELIGIBILITY

Any person of full age (18 years or over) shall be eligible to hold the office of People's Deputy provided that the person:

- (a) is ordinarily resident in Guernsey on the date of the person's nomination as a candidate for that office; **and**
- (b) has been ordinarily resident in Guernsey –
 - (i) for a period of two years immediately before that date; or
 - (ii) for a period or periods of at least five years in the aggregate at any time before that date; **and**
- (c) has not at any time during the five years immediately preceding the date of the election been sentenced for an offence by a court in the United Kingdom, any of the Channel Islands or the Isle of Man, to imprisonment for a period of six months or more (whether suspended or not) without the option of a fine, unless that sentence was quashed or reduced to less than six months on appeal; **and**
is neither imprisoned nor detained in the United Kingdom, any of the Channel Island or the Isle of Man, nor is unlawfully at large, after having been sentenced for an offence by a court (whether in the Bailiwick or elsewhere) to imprisonment for a period of one year or more; **and**
- (d) is inscribed on the Electoral Roll.

- b) the person's unspent convictions which resulted in sentences of imprisonment defined in the [Rehabilitation of Offenders \(Bailiwick of Guernsey\) Law, 2002](#) in any jurisdiction anywhere in the world, other than convictions in respect of an act or default which would not constitute an offence if committed in Guernsey; or, if there are no such unspent convictions, declaring that to be the case.

The Law requires disclosure of any criminal convictions resulting in sentences of imprisonment which are not to be treated as spent pursuant to the [Rehabilitation of Offenders \(Bailiwick of Guernsey\) Law, 2002](#) ("unspent convictions"). In broad terms, such a conviction is "unspent" until the end of the following periods, according to the length of prison sentence imposed in respect of it:

Imprisonment (including a suspended sentence of imprisonment) for a term exceeding six months but not exceeding 30 months	10 years after the date of conviction, or five years if the person was under 18 when convicted
Imprisonment (including a suspended sentence of imprisonment) for a term not exceeding six months	Seven years after the date of conviction, or three years and six months if the person was under 18 when convicted

It is important to note that convictions recorded outside the Bailiwick are equally subject to rehabilitation, and are "unspent" for the same periods. The only exception is that the Law does NOT require the unspent conviction to be declared if the conduct concerned would not constitute an offence if committed in Guernsey. **A conviction resulting in a sentence in excess of 30 months' imprisonment is never spent, and must be declared irrespective of its date.**

Delivery of the nomination form

The original version of the completed nomination form must be delivered by hand to the Bailiff's Secretary between **9.00 a.m.** on Monday 12th May and **4.30 p.m.** on Wednesday 14th May. **Please note that forms will not be accepted before or after that period.**

The form cannot be submitted by post, fax, e-mail or other electronic means. The nomination form may only be delivered by the candidate or someone they have specifically authorised for this purpose (and they will need to provide the Presiding Officer with notification of this prior to the form being submitted).

The Presiding Officer will accept only the first valid nomination form delivered to him.

Information checks

The member of staff who receives the form will check that the candidate, proposer and seconder are validly inscribed on the Electoral Roll.

The Presiding Officer may in respect of any declaration of unspent convictions, as set out above, take such steps as he considers necessary to verify the information in the declaration. Please note that the declaration will be destroyed as soon as reasonably practicable after the conclusion of the election to which it relates.

Any information that a candidate, proposer and seconder provide on the nomination form must be true to the best of their knowledge.
